

BRITISH GUIANA.

NOTICE**THE INTERPRETATION ORDINANCE,**

(Chapter 5).

UNDER SECTION 39 OF THE INTERPRETATION ORDINANCE, IN ACCORDANCE WITH ARTICLE 22 OF THE CONSTITUTION OF BRITISH GUIANA, AND BY VIRTUE AND IN EXERCISE OF ALL POWERS ENABLING HIM IN THAT BEHALF, HIS EXCELLENCY THE GOVERNOR ON THE 9TH DAY OF AUGUST, 1962, DEPUTED THE MINISTER OF EDUCATION AND SOCIAL DEVELOPMENT TO EXERCISE ON HIS BEHALF THE POWERS SPECIFIED IN THE FIRST COLUMN OF THE SCHEDULE TO THIS NOTICE CONFERRED ON THE GOVERNOR BY THE ORDINANCES MENTIONED IN THE SECOND COLUMN OF THE SAID SCHEDULE, SUBJECT HOWEVER TO THE FOLLOWING QUALIFICATIONS:—

That the delegation of powers mentioned herein shall remain in force only until varied or revoked by the Governor.

SCHEDULE

Power delegated	Ordinance
1. To appoint from time to time such fit and proper persons, not less than five in number who shall together constitute a Board of Film Censors for the purpose of censoring cinematograph films and posters and to nominate one of the censors as Chairman of the Board.	The Cinematograph Ordinance, Chapter 127. (Section 4(1)).
2. To remove at his pleasure any member of the Board of Film Censors and to appoint some other person in his stead.	The Cinematograph Ordinance, Chapter 127. (Section 4(3)).
3. To grant leave of absence to any member of the Board of Film Censors and to temporarily fill the vacant place or places during such absence.	The Cinematograph Ordinance, Chapter 127. (Section 4(4)).

Power delegated	Ordinance
4. To appoint a person to act in the place of any member of the Board of Film Censors who shall become ill or incapable of performing his duties.	The Cinematograph Ordinance, Chapter 127. (Section 4(5)).
5. To fill vacancies among members of the Board of Film Censors.	The Cinematograph Ordinance, Chapter 127. (Section 4(6)).
6. To approve of the appointment of a Secretary to the Board of Film Censors at such remuneration and upon such conditions as the Chairman may determine.	The Cinematograph Ordinance, Chapter 127. (Section 4(8)).
7. To appoint the Chairman and nominate four members of the Public Free Library Committee and to nominate a person to take the place of a person so appointed or nominated who has died, resigned or been absent from the Colony without leave for a longer period than three months.	The Public Free Library Ordinance, Chapter 160. (Section 5(1)).
