Cde. Ally to ask the Minister of Education, Social Development and Culture the following question:

QUESTION:

Will the Minister of Education, Social Development and Culture say whether or not he knows that the children of the No. 48 and No. 56 Schools, Corentyne, were informed that the two schools will be converted into Community High Schools from September, 1977, and that they will have to go to the Nos. 59 - 51 and No. 45 Primary Schools?

If the answer is in the affirmative, will the Minister say whether he is aware of the fact that the schools to which the children are to be removed are already overcrowded, so much so that one hundred of them from the No. 59 School are being accommodated in the No. 58 Community Centre?

Is the Minister aware that the No. 56 School at present accommodates 721 children, and that there are 540 children at the No. 48 School?

Is the Minister aware that there is an unfinished secondary school building at No. 54 Village and that if this building is completed it could take care of all the children from the Nos. 59-51 and No. 45 Schools?
