1. SUPPORT TO GOVERNMENT AND PEOPLE OF BELIZE

The Minister of Energy and Natural Resources to move the following motion:

BE IT RESOLVED:

That this National Assembly viewing with great concern recent developments regarding the future of Belize including the proposals to settle the dispute through cession of territory pledges its unconditional and unstinting support for the Government and people of Belize in their determination to achieve early and secure independence with full sovereign and territorial integrity.

2. CONDEMNATION OF INVASION OF ZAMBIAN TERRITORY

The Minister of Energy and Natural Resources to move the following motion:

BE IT RESOLVED:

That this National Assembly condemns the recent invasion of Zambian territory by the military forces of the illegal minority racist regime in Zimbabwe and pledges its full support to the Government and people of Zambia in their commitments to the advancement of the struggle for self-determination in Southern Africa and particularly for the restoration of the legitimate rights of the majority of the people of Zimbabwe.
