2. CONDEMNATION OF SOMOZA REGIME AND RECOGNITION OF GOVERNMENT OF NATIONAL RECONSTRUCTION

The Leader of the Opposition to move the following motion:

WHEREAS the brutal Somoza regime is carrying out a genocidal war against the people of Nicaragua;

AND WHEREAS the heroic people of Nicaragua, led by the Sandinista Front need urgent international solidarity and support;

AND WHEREAS several Latin American and Caribbean Governments, including the People's Revolutionary Government of Grenada, have broken off relations with the Somoza regime and recognised the Government of National Reconstruction of Nicaragua:

BE IT RESOLVED:

That this National Assembly condemns the Somoza dictatorship and calls upon the Government to express solidarity with the Committee for National Salvation led by the Sandinista Front and to recognise the new Government of National Reconstruction.
