A BILL intituled AN ACT TO AMEND THE CONSTITUTION IN ACCORDANCE WITH ARTICLE 73 THEREOF FOR THE PURPOSE OF REDUCING THE AGE OF MAJURITY FOR ELECTORAL AND OTHER PURPOSES AND FOR DETERMINING THE NUMBER OF MINISTERS WHO MAY BE APPOINTED FROM AMONY PERSONS WHO ARE NOT ELECTED MEMBERS OF THE NATIONAL ASSEMBLY, AND TO MAKE PROVISION FOR THE ADAPTATION AND MODIFICATION OF LAWS RELATING TO THE ELECTION OF MEMBERS OF THE NATIONAL ASSEMBLY, FOR REDUCING THE AGE OF MAJURITY GENERALLY, AND FOR MATTERS CONNECTED THEREWITH.
