GUARANTEE OF LOAN TO GUYANA DEVELOPMENT CORPORATION

1. The Minister of Finance to move the following motion:

WHEREAS in accordance with section 20(1) of the Public Corporations Ordinance, 1962 (No. 23), with the approval of the National Assembly, the Cabinet may guarantee in such manner and on such conditions as they may think fit, the payment of the principal and of interest on any authorised borrowings of a corporation;

AND WHEREAS in accordance with section 2 of the said Ordinance, corporation means a public corporation established under the said Ordinance;

AND WHEREAS the Guyana Development Corporation was established under the Guyana Industrial Development Corporation Order, 1963, as amended by the Guyana Industrial Development Corporation (Amendment) Order, 1966;

AND WHEREAS the Guyana Development Corporation needs the sum of four million U.S. dollars for a period of twelve months in relation to the take-over of the Demerara Bauxite Company Ltd.;

AND WHEREAS the Chase Manhattan Bank, N.A. is willing to provide this sum for the purpose on the basis of a guarantee by the Government of Guyana;

BE IT RESOLVED:

That this National Assembly approve of the Government of Guyana guaranteeing the repayment of a short-term loan of four million United States dollars to be made by the Chase Manhattan Bank, N.A. to the Guyana Development Corporation for a period of twelve months in relation to the take-over of the Demerara Bauxite Company Ltd.
