ORDER

THE CONSTITUTIONAL OFFICES (REMUNERATION OF HOLDERS)
ORDINANCE, 1962

(No. 26 of 1962)

UNDER SECTION 3 OF THE CONSTITUTIONAL OFFICES (REMUNERATION OF HOLDERS) ORDINANCE, 1962, AND BY VIRTUE AND IN EXERCISE OF ALL OTHER POWERS ENABLING ME IN THAT BEHALF, I HEREBY MAKE THE FOLLOWING ORDER —

1. (1) This Order may be cited as the Constitutional Offices (Holders' Allowances) (Amendment) Order, 1969, and shall be construed and read as one with the Constitutional Offices (Holders' Allowances) Order, 1963, hereinafter referred to as the Principal Order, and all amendments thereto.

(2) This Order shall be deemed to have come into operation on 1st January, 1968.

2. Article 5 of the Principal Order is hereby amended in the following respects —

- (a) by the insertion of the words "the Director of Audit and the Commissioner of Police" between the words "Commission," and "shall" in paragraph (1);
- (b) by the substitution of the word "forty" for the word "twenty-five" in paragraph (1);
- (c) by the substitution of the words "area described in the schedule to this Order" for the words "City of Georgetown" wherever they appear in paragraph (2) and where they first appear in paragraph (4);
- (d) by the substitution of the following subparagraph for subparagraphs (a) and (b) of paragraph (2) —
 "(a) travelling allowance at the rate of 30 cents per mile for every mile travelled in a car owned by him;";
- (e) by re-lettering subparagraph (c) of paragraph (2) as subparagraph (b);

- (f) by the substitution of the word "thereinto" for the words "into the said City" in the proviso to paragraph (2);
- (g) by the substitution of the symbols and word "(a) and (b)" for the symbols and word "(a), (b) and (c)" in paragraph (4); and
- (h) by the deletion of the words and symbols "appropriate" and "or (b)" from paragraph (5), and the substitution of the symbol "(b)" for the symbol "(c)" appearing therein.

3. Paragraph (2) of article 6 of the Principal Order is hereby amended by the insertion of the words "the Director of Audit and the Commissioner of Police" immediately after the word "Commission".

4. The Principal Order is hereby amended by the addition of the schedule hereto as the schedule thereto.

The area bounded as follows —

On the North	—	By the Atlantic Ocean.
On the South	—	By the Northern Side Line of Pln. Ruimveldt, extending from the Demerara River eastwards to its intersection with the prolongation of the Western Side Line of Plantation Sophia.
On the East	—	By the Western Side Line of Plantation Sophia and its prolongation southwards to the Southern boundary.
On the West	—	By the Right Bank of the Demerara River."
