ORDER

MADE UNDER

**THE CUSTOMS ORDINANCE,
(Chapter 309).**

**UNDER SECTION 8 OF THE CUSTOMS ORDINANCE AND BY VIRTUE
AND IN EXERCISE OF ALL OTHER POWERS ENABLING HIM IN
THAT BEHALF, IT IS HEREBY ORDERED BY THE MINISTER
RESPONSIBLE FOR FINANCE AS FOLLOWS:—**

1. This Order may be cited as the Customs Duties (Amendment) (No. 3) Order, 1969.

2. Part 1 of the First Schedule to the Customs Ordinance is hereby amended —

- (a) by the deletion of the brackets, abbreviations, words, symbols and figures, signifying a Carifta rate of duty, and set out in the column headed "Preferential tariff" in the Trade Classification List and Tariff against the following item numbers, respectively—
 122 — 01; 632 — 02.2; 721 — 04.1;
 122 — 03.4; 632 — 09.1; 721 — 04.3;
 632 — 02.1; 632 — 09.9;
- (b) by the insertion immediately after the figures and symbol "20%" appearing within the brackets in the aforementioned column against item number "533 — 03.6" of the words "except in relation to Artists' colours."
- (c) by the substitution for the rate of import duty set out within brackets as a Carifta rate of duty in the said Part against each item number mentioned in the first column of this schedule to this Order, of the rate of import duty set out in the second column of the last mentioned schedule against the same, respectively —
