GUYANA

ORDER

MADE UNDER

THE CUSTOMS ORDINANCE
(Chapter 309).

UNDER SECTION 8 OF THE CUSTOMS ORDINANCE AND BY VIRTUE AND IN EXERCISE OF ALL OTHER POWERS ENABLING HIM IN THAT BEHALF, IT IS HEREBY ORDERED BY THE MINISTER RESPONSIBLE FOR FINANCE AS FOLLOWS:—

1. This Order may be cited as the Customs Duties (Amendment) (No. 5) Order, 1969.

2. Part 1 of the First Schedule to the Customs Ordinance as amended by the Customs Duties (Amendment) (No. 3) Order* is hereby further amended—

- (a) by the insertion of the words “except in relation to brassieres” immediately after the figures and symbol “40%” appearing within the brackets in the column headed “Preferential Tariff” against the following item numbers, respectively,—
841 — 04.61; 841 — 04.64;
841 — 04.62; 841 — 04.65;
841 — 04.63;
- (b) by the addition in the abovementioned column in relation to item number “122 — 03.4” of “[Carifta rate: \$8.08 per lb]”;
- (c) by the substitution for the rate of import duty set out within brackets as a Carifta rate of duty in the said Part against each item number mentioned in the first column of the schedule to this Order, of the rate of import duty set out in the second column of the last mentioned schedule against the same, respectively; and
- (d) by the substitution for the words “a like Carifta rate of duty being applicable in addition to any other Carifta rate of duty hereinbefore imposed thereon” appearing at the end of each of the further provisos (1), (2) and (3) to the Trade Classification List and Tariff in the said Part, of the words “though where a Carifta rate of duty is hereinbefore imposed thereon, the additional duty shall be eighty per centum of that herein previously mentioned”.
