

## ORDER

Made Under

THE CUSTOMS ORDINANCE,  
(Chapter 309)

UNDER SECTION 8 OF THE CUSTOMS ORDINANCE, I HEREBY MAKE THE FOLLOWING ORDER:-

1. This Order may be cited as the Customs Duties (Amendment) (No. 2) Order, 1970.
2. During the continuance in force of this Order -
  - (a) the rate of import duty set out in the second column of the Schedule against the respective item number specified in the first column thereof shall be payable in lieu of the rate of duty set out as a Carifta rate against the same item number in the column headed "Preferential Tariff" in Part I of the First Schedule to the Customs Ordinance.

(b) paragraphs (2), (3) and (4) of the proviso to the abovementioned Part are hereby respectively amended by the substitution of the word "sixty" for the word "eighty", wherever it appears.
