THE CONSUMPTION TAX ACT, 1969

(No. 13 of 1969).

UNDER SECTION 4 OF THE CONSUMPTION TAX ACT, 1969, IT IS HEREBY

ORDERED AS FOLLOWS:-

1. (1) This Order may be cited as the Consumption Tax (Petroleum) Order, 1971.

(2) This Order shall be deemed to have come into operation on the 1st May, 1970.

2. In relation to the period mentioned in the third, fourth, fifth and sixth columns, respectively, of the schedule, there shall be imposed upon the imported chargeable goods specified in the second column of that schedule, being goods of the respective item number mentioned in the first column thereof, a tax at the rate respectively set out against such goods.

3. The Consumption Tax (Petroleum) Order, 1969* is hereby revoked.
