THE TRADE ORDINANCE, 1958

(No. 34 of 1958).

**UNDER SECTION 5 OF THE TRADE ORDINANCE, 1958, IT IS
HEREBY ORDERED AS FOLLOWS:—**

1. This Order which amends the Trade (Control of Prices) (Amendment) Order, 1969*, may be cited as the Trade (Control of Prices) (Amendment) (No. 49) Order 1973.

2. Part A of the First Schedule to the Principal Order is hereby amended by the substitution for the particulars appearing in the third, fourth and fifth columns, respectively, of that Part against the article of foodstuff mentioned in the column thereof and numbered 35 (Chocolate Bars), of the particulars appearing in the third, fourth and fifth columns of Part A of the Schedule to this Order against the same article of foodstuff mentioned in the said column thereof and of the said number.

Part B of the First Schedule to the Principal Order is hereby amended by the substitution for the particulars appearing in the third, fourth and fifth columns, respectively, of that Part against the article of foodstuff mentioned in the column thereof and numbered 35 (Chocolate Bars), of the particulars appearing in the third, fourth and fifth columns of Part B of the Schedule to this Order against the same article of foodstuff mentioned in the said column thereof and of the said number.
