THE TRADE ACT

(Cap. 91:01)

IN EXERCISE OF THE POWER CONFERRED UPON THE PRESIDENT BY SECTION 5 OF THE TRADE ACT, I HEREBY ORDER AS FOLLOWS:—

Citation.

1. This Order may be cited as the Trade (Control of Prices) (Ale, Beer and Stout) Order 1974 and shall be construed and read as one with the Trade (Control of Prices) Order.*

Interpreta-

- 2. In this Order
 - a reference to sale by wholesale -
 - (a) includes 'the sale of ale, beer and stout by a manufacturer; and
 - (b) implies that the wholesaler shall deliver, ale, beer and stout to premises specified by the buyer.

Maximum wholesale prices.

3. The maximum prices at which ale, beer and stout, described in the first column of Part A of the Schedule shall be sold by wholesale, shall be as set out in the second, third and fourth columns of the said Part.

Maximum retail prices.

4. The maximum prices at which ale, beer and stout described in the first column of Part B of the Schedule shall be sold by retail, shall be as set out in the second, third and fourth columns of the said Part.

Sale by retail at entertainment etc.

- 5. Nothing in clause 4 shall affect the sale of ale, beer and stout at
 - (a) any entertainment held for the exclusive benefit of any religious, educational or charitable object;

- (b) any cinematographic entertainment;
- (c) such events or functions as the Competent Authority, may, pursuant to applications made to him in that behalf, approve; or
- (d) in any premises licensed as an hotel or in any refreshment bar in the Timehri International Airport Building.
