## THE TRADE ACT

(Cap. 91:01)

IN EXERCISE OF THE POWERS CONFERRED UPON ME BY SECTION 5 OF THE TRADE ACT, I HEREBY ORDER AS FOLLOWS:—

- 1. This Order may be cited as the Trade (Control of Imports) Order 1974.
- 2. The importation into Guyana of the goods specified in the schedule, not being goods which are entitled to be accorded a Community rate of duty or an Association rate of duty within the meaning of section 15 of the Customs Act, is hereby prohibited.
- 3. It shall be lawful for the Competent Authority or any person authorised by him in that behalf to enter and inspect any premises for the purpose of securing compliance with this Order.
- 4. For the purpose of securing compliance with this Order any person carrying on or employed in connection with any trade or business shall produce to the Competent Authority or any person authorised in writing in that behalf by the Competent Authority such books, accounts or other documents relating to his trade or business as the Competent Authority may require, and shall furnish to the Competent Authority such documents or information as the Competent Authority may, from time to time, require.
- 5. The provisions of this Order shall have effect nothwithstanding the provisions of any other order now in force under the Act in respect of the importation under licence of any good specified in the schedule.
