THE TRADE ACT

(Cap. 91:01)

IN EXERCISE OF THE POWER CONFERRED UPON THE MINISTER BY SECTION 5 OF THE TRADE ACT, I HEREBY ORDER AS FOLLOWS:—

1. This Order which amends the Trade (Control of Prices) Order* may be cited as the Trade (Control of Prices) (Amendment) (No. 49) Order 1974.

2. The Principal Order is hereby amended —

- (a) by the substitution in Part A of the Fourth Schedule thereto, for the particulars specified in the third, fourth and fifth columns respectively, in relation to the article numbered (Baby Foods), of the particulars specified in the third, fourth and fifth columns, respectively of Part A of the Schedule to this Order in relation to the same article and the said number; and
- (b) by the substitution in Part B of the Fourth Schedule thereto, for the particulars specified in the third, fourth and fifth columns respectively, in relation to the article numbered (Baby Foods), of the particulars specified in the third, fourth and fifth columns, respectively of Part B of the Schedule to this Order in relation to the same article and the said number;
