IN EXERCISE OF THE POWER CONFERRED UPON ME BY SECTION 5 OF THE TRADE ACT, I HEREBY MAKE THE FOLLOWING ORDER:—

1. This Order which amends the Trade (Control of Prices) Order* Citation. may be cited as the Trade (Control of Prices) (Amendment) (No. 37) Order 1975.

2. The Principal Order is hereby amended —

- (b) by the substitution in Part B of the Fourth Schedule thereto for the particulars specified in the third, fourth and fifth columns, respectively, thereto in relation to the article numbered 1 (Butter), of the particulars specified in the third, fourth and fifth columns respectively, of Part B of the Schedule to this Order, in relation to the same article and to the said number.
