IN THE EXERCISE OF THE POWER CONFERRED UPON THE MINISTER
BY SECTION 5 OF THE TRADE ACT, I HEREBY ORDER AS
FOLLOWS:—

1. This Order which amends the Trade (Control of Prices) ^{Citation.}
Order* may be cited as the Trade (Control of Prices) (Amend-
ment) (No. 48) Order 1975.
