THE CUSTOMS ACT

(Cap. 82:01)

IN EXERCISE OF THE POWERS CONFERRED UPON ME BY SECTION 8 OF THE CUSTOMS ACT I HEREBY MAKE THE FOLLOWING ORDER:—

1. This Order may be cited as the Customs Duties (Amendment) (No. 2) Order 1976.
2. The Import Schedule in Part I of the First Schedule to the Act is hereby amended in the following respects —
 - (a) by the substitution for the Statistical Classification Number “845.91” appearing against the Tariff Heading Number 32.13.9, of the Statistical Classification Number “895.91”;
 - (b) by the insertion in the columns headed “Tariff Heading Number”, “Tariff Description” and “Rate of Duty” respectively against the words “For men and boys:” appearing immediately under the particulars relating to Tariff Heading Number 60.04.1 of the words “60.04.9”, “Other”, and “45%” respectively;

(c) by the substitution for the particulars appearing against Tariff Heading Numbers 84.20, 84.20.1 and 84.20.9 respectively in the columns headed "Rate of Duty", "Statistical Classification" — "Number" and "Description", and "Unit (s)" of the particulars appearing against Tariff Heading Number 84.20 as shown in the respective columns of the First Schedule to this Order;

(d) by the substitution in the respective columns for the particulars appearing against Tariff Heading Number 87.02 of the particulars appearing in the respective columns of the Second Schedule to this Order;

(e) by the substitution for the words "(INCLUDING EXPOSURE METERS)" appearing in the column headed "Tariff Description", against the Tariff Heading Number 90.25 of the words "(INCLUDING EXPOSURE METERS)";

(f) by the insertion in the column headed "Rate of Duty" of the rates of duty appearing against the respective Tariff Heading Numbers mentioned in the Third Schedule to this Order.
