THE ACQUISITION OF LANDS FOR PUBLIC PURPOSES ACT

(Cap. 62:05)

IN EXERCISE OF THE POWER CONFERRED UPON ME BY SECTIONS 3 AND 4 OF THE ACQUISITION OF LANDS FOR PUBLIC PURPOSES ACT, I HEREBY MAKE THE FOLLOWING ORDER:—

1. This Order may be cited as the Acquisition of Lands for Public Purposes (Demerara Harbour Bridge) Order, 1976.

2. The proposed construction, operation and maintenance of the Demerara Harbour Bridge on the Lands described in the schedule hereunder is hereby declared to be a public work.

3. The Chief Works Officer, together with his agents, servants and workmen, is hereby authorised to enter upon the said lands for the purpose of surveying or, otherwise examining such lands with a view to the acquisition of the whole or part of such lands for the public work aforesaid.

SCHEDULE:

LANDS.

(a) That part of Plantation Peter's Hall, including portion of that section known as Bagotstown Village, situate on the East Bank of the Demerara River, between the East Bank Demerara Public Road and the Demerara River, and bounded as follows:—

| ON THE NORTH: | By portion of the Peter's Hall Christian Brethren Church Compound and portions of contiguous lots extending northwards to the northern boundary of lot 7, Bagotstown Village, East Bank Demerara. |
| ON THE EAST:  | By the East Bank Demerara Public Road.  |
| ON THE SOUTH: | i) By the Brick Road immediately South of and parallel to the Bagotstown/Peter's Hall Drainage Trench.  |

- ii) By the Southern Boundary of portion of a strip of land approximately 100 feet wide. The said portion of land extends southwards generally for approximately 760 feet from the western extremity of the aforementioned Brick Road, and lies East of and adjacent to the river dam.

ON THE WEST: By Mean Low Water Mark of the Demerara River.

(b) That portion of Plantation Meer Zorgen, situate on the West Bank of the Demerara River, between the Schoonord-La Grange deviation of the West Bank Demerara Public Road, and the Demerara River, and bounded as follows:—

ON THE NORTH: By the Meer Zorgen North Side Line Trench and its prolongation eastwards to Mean Low Water Mark of the Demerara River.

ON THE EAST: By Mean Low Water Mark of the Demerara River.

ON THE SOUTH: By the Meer Zorgen South Side Line Trench and its prolongation generally eastwards to Mean Low Water Mark of the Demerara River.

ON THE WEST: By the Schoonord-La Grange deviation of the West Bank Demerara Public Road.

(c) A transverse strip of a portion of the Demerara River, approximately 2000 feet wide and extending for approximately 6000 feet from the western boundary of area (a) to the eastern boundary of area (b) described above.
