ORDER

MADE UNDER

THE ACQUISITION OF LANDS FOR PUBLIC PURPOSES ACT

(Chapter 62:05)

WHEREAS by the Acquisition of Lands for Public Purposes (Mechanical Workshop) Order 1975\* made on the 11th day of March, 1975, the proposed construction of a mechanical workshop on the land described in the schedule to that Order was declared to be a public work under section 3 of the Acquisition of Lands for Public Purposes Act;

AND WHEREAS by the said Order the Chief Works Officer together with his agents, servants or workmen was authorised under section 4 of the Act to enter upon the said land for the purpose of surveying or otherwise examining such land with a view to the acquisition of the whole or a part thereof for the construction of the public work aforesaid;

AND WHEREAS in accordance with the provisions of section 6 of the Act, the report of the Chief Works Officer and a plan of the land to be acquired have been laid before the Minister;

NOW THEREFORE, in accordance with the provisions of the said section 6, it is hereby declared —

- (i) that the Acquisition of Lands for Public Purposes (Mechanical Workshop) Plantation Houston Order 1976\*\* is hereby annulled;

- (ii) that the land described in the schedule to this Order is required for the public work aforesaid.

This Order may be cited as the Acquisition of Lands for Public Purposes (Mechanical Workshop) (Plantation Houston) (No. 2) Order 1976.

### SCHEDULE

That portion of land being part of Plantation Houston, situate on the East Bank of the Demerara River commencing from an iron paal marked HOD adjacent to a wooden paal marked K.N.M. situate at the north-western corner of Lot 'A' and extending thence N104° 07' 00" (tr.) for a distance of 995.89 ft. to a wooden paal marked K.N.M. thence N196° 26' 00" (tr.) for a distance of 224.63 ft. to a wooden paal marked K.N.M. thence N283° 32' 00" (tr.) for a distance of 995.20 ft. thence N283° 37' 00" (tr.) for a distance of 307.30 ft. to a wooden paal marked K.N.M. thence N12° 49' 00" (tr.) for a distance of 242.00 ft. to a wooden paal marked K.N.M. thence N104° 55' 00" (tr.) for a distance of 321.20 ft. to the iron paal marked H.O.D. at the point of commencement, the said portion of land contains an area of 6.969 acres and is shown bordered red as area 'X' on a plan by K. N. Maraj, Sworn Land Surveyor, dated 8th September, 1975, on record in the Lands and Surveys Department of the Ministry of Agriculture as plan No. 16874. The said Lot 'A' is shown on a plan by H. O. Durham, Sworn Land Surveyor, dated 10th August, 1922, on record in the said Land Department as plan No. 2959.
