IN EXERCISE OF THE POWERS CONFERRED
UPON THE MINISTER BY SECTION 10
OF THE MINING ACT, 1989, I HEREBY
MAKE THE FOLLOWING ORDER:-

- Citation.** 1. This Order may be cited as the Guyana Geology and Mines Commission (Prospecting and Mining for Minerals and Metals) Reservation Order, 2011.
- Reservation.** 2. The area hereinafter described in the Schedule below is hereby reserved by the Guyana Geology and Mines Commission for prospecting and mining of minerals and metals but WITHOUT PREJUDICE to the power of the Minister (as representing the State) to permit any person to carry on in the scheduled area mining or prospecting operations (including operations incidental thereto) for the benefit, wholly or partly, of the Guyana Geology and Mines Commission.

SCHEDULE I

Tract of state land located in the Potaro Mining District No. 2 as shown on Terra Surveys Topographic Map 43SE, at scale 1:50,000, with reference point 'X', located at the confluence of North Fork River and Minnehaha River, with geographical coordinates of longitude 59°8'15"W and latitude 5°8'49"N

Thence at a true bearing of 262°, for a distance of 2 miles 536 yards to the point of commencement

Point A, located at geographical coordinates of longitude 59°10'14"W and latitude 5°8'31"N, thence at true bearing of 238°, for a distance of approximately 490 yards, to Point B, located at geographical coordinates of longitude 59°10'27"W and latitude 5°8'23"N, thence at true bearing of 218°, for a distance of approximately 344 yards, to Point C, located at geographical coordinates of longitude 59°10'33"W and latitude 5°8'15"N, thence at true bearing of 327°, for a distance of approximately 267 yards, to Point D, located at geographical coordinates of longitude 59°10'38"W and latitude 5°8'22"N, thence at true bearing of 345°, for a distance of approximately 235 yards, to

Point E, located at geographical coordinates of longitude **59°10'40"W** and latitude **5°8'28"N**, thence at true bearing of **34°**, for a distance of approximately **376 yards**, to **Point F**, located at geographical coordinates of longitude **59°10'33"W** and latitude **5°8'38"N**, thence at true bearing of **64°**, for a distance of approximately **361 yards**, to **Point G**, located at geographical coordinates of longitude **59°10'24"W** and latitude **5°8'42"N**, thence at true bearing of **141°**, for a distance of approximately **492 yards**, to the point of commencement at **Point A**.

Thus enclosing an area of approximately **80 acres**, save and except all lands lawfully held or occupied.
