THE LOCAL AUTHORITIES (ELECTIONS) ACT

(Cap. 28:03)

IN EXERCISE OF THE FUNCTIONS CONFERRED ON THE ELECTIONS COMMISSION, TO BE EXERCISED AND DISCHARGED THROUGH THE CHAIRMAN THEREOF, BY SECTION 8 OF THE LOCAL AUTHORITIES (ELECTIONS) ACT AS AMENDED BY SECTION 4 OF THE LOCAL AUTHORITIES (ELECTIONS) (AMENDMENT) ACT 1990, THE ELECTIONS COMMISSION HEREBY MAKES THE FOLLOWING ORDER THROUGH ITS CHAIRMAN:—

Citation.

1. This Order may be cited as the Anna Regina Municipal Council (Registration of Voters) Order 1990.

Preparation of register of voters, First Schedule

2. The electoral registrar of the local authority area described in the First Schedule is required to prepare a register of voters for that local authority area.

Qualifying date.

3. The 30th June, 1990, shall be the qualifying date with reference to which a register of voters shall be compiled in pursuance of this Order.

Other matters prescribed, Second Schedule

4. The days set out in the second column of the Second Schedule shall be the days with reference to which the matters set out in the corresponding entry in the first column therefore shall be done.

- (5) The day not later than which the electoral registrar shall hear and determine objections and applications for correction of particulars under section 20 of the Act. Monday, 25th
- (6) The day not later than which the electoral registrar shall correct the preliminary and supplementary lists under section 22 of the Act. Tuesday, 26th
