THE LOCAL DEMOCRATIC ORGANS ACT 1980

(Act No. 12 of 1980)

IN EXERCISE OF THE POWERS CONFERRED UPON BE BY
SECTIONS 9 AND 50 OF THE LOCAL DEMOCRATIC ORGANS
ACT 1980, I HEREBY MAKE THE FOLLOWING ORDER :-

1. This Order may be cited as the Local Democratic ~~Council~~
Organs (Emoluments of Office-holders) Order 1989.

2. In this Order "regional democratic council" means
~~an~~ regional democratic council established by a constitution ~~Interpre-~~
tation.

3.(1) The Mayor of Georgetown shall be paid each
month — ~~Emolu-~~

- (a) with effect from 1st. January, 1987 a salary of
three thousand eight hundred and one dollars
and sixty-nine cents, from 1st. January, 1988 a
salary of four thousand three hundred and
ninety dollars and ninety-five cents and from
1st. April, 1989 a salary of five thousand two
hundred and sixty-nine dollars and fourteen
cents;

- (b) (i) a duty allowance of four hundred dollars;
and
- (ii) an entertainment allowance of five hundred dollars.

(2) The Deputy Mayor of Georgetown shall be paid each month —

- (a) with effect from 1st. January, 1987 a salary of two thousand four hundred and sixty-nine dollars and eight cents, from 1st. January, 1988 a salary of two thousand eight hundred and fifty-one dollars and seventy-eight cents and from 1st. April, 1989 a salary of three thousand four hundred and twenty-two dollars and fourteen cents;
- (b) (i) a duty allowance of two hundred dollars;
and
- (ii) an entertainment allowance of one hundred and fifty dollars.

4.(1) The Mayor of New Amsterdam shall be paid each month —

- (a) with effect from 1st. January, 1987 a salary of one thousand nine hundred and thirty-five dollars and fifty-five cents, from 1st. January, 1988 a salary of two thousand two hundred and thirty-five dollars and fifty-six cents and from 1st. April, 1989 a salary of two thousand six hundred and eighty-two dollars and sixty-seven cents;
- (b) (i) a duty allowance of two hundred dollars;
and
- (ii) an entertainment allowance of two hundred dollars.

(2) The Deputy Mayor of New Amsterdam shall be paid each month —

- (a) with effect from 1st. January, 1987 a salary of one thousand three hundred and twenty-three dollars and seventy-cents, from 1st. January, 1988 a salary of one thousand five hundred and eighty-eight cents and from 1st. April, 1989 a salary of one thousand eight hundred and thirty-four dollars and sixty-six cents;

- (b) (i) a duty allowance of one hundred and fifty dollars; and
- (ii) an entertainment allowance of one hundred and fifty dollars.

5.(1) The chairman of the National Congress of Local Democratic Organs shall be paid each month —

- (a) with effect from 1st. January, 1987 a salary of three thousand nine hundred and forty-nine dollars and seventy-six cents, from 1st. January, 1988 a salary of four thousand five hundred and sixty-one dollars and ninety-eight cents and from 1st. April, 1989 a salary of five thousand four hundred and seventy-four dollars and thirty-eight cents;

- (b) (i) a duty allowance of three hundred dollars;
- (ii) an entertainment allowance of three hundred dollars; and
- (iii) with effect from 1st. January, 1987 a commuted travelling allowance of one thousand two hundred and thirty-two dollars, or in lieu of such travelling allowance, shall be provided with an official car for use on official duties.

(2) The chairman of the National Congress of Local Democratic Organs shall be entitled to occupy free of rent a furnished residence provided by the Government, or in lieu thereof, to be paid each month a house allowance of four hundred and fifty dollars.

(3) The vice-chairman of the National Congress of Local Democratic Organs shall be paid each month —

- (a) with effect from 1st. January, 1987 a salary of two thousand nine hundred and eighty-seven dollars and ninety-three cents, from 1st. January, 1988 a salary of three thousand four hundred and fifty-one dollars and six cents and from 1st. April, 1989 a salary of four thousand one hundred and forty-one dollars and twenty-seven cents;
- (b) (i) a duty allowance of three hundred dollars;
- (ii) an entertainment allowance of three hundred dollars; and

- (iii) with effect from 1st. January, 1987 a commuted travelling allowance of one thousand two hundred and thirty-two dollars, or in lieu of such travelling allowance, shall be provided with an official car for use on official duties.

6.(1) The chairman of the regional democratic council shall be paid each month —

- (a) with effect from 1st January, 1987 a salary of three thousand eight hundred and one dollars and sixty-nine cents, from 1st. January, 1988 a salary of four thousand three hundred and ninety dollars and ninety-five cents and from 1st. April, 1989 a salary of five thousand two hundred and sixty-nine dollars and fourteen cents;
- (b) (i) a duty allowance of five hundred dollars;
- (ii) an entertainment allowance of five hundred dollars; and
- (iii) with effect from 1st. January, 1987 a commuted travelling allowance of one thousand two hundred and thirty-two dollars, or in lieu of such travelling allowance, shall be provided with an official car for use on official duties.

(2) The chairman referred to in paragraph (1) shall be entitled to occupy free of rent a furnished residence provided by the Government, or in lieu thereof, to be paid each month a house allowance of four hundred and fifty dollars.

(3) The vice-chairman of the regional democratic council shall be paid each month —

- (a) with effect from 1st. January, 1987 a salary of two thousand nine hundred and fourteen dollars and fifty-one cents, from 1st. January, 1988 a salary of three thousand three hundred and sixty-six dollars and twenty-six cents and from 1st. April, 1989 a salary of four thousand and thirty-nine dollars and fifty-one cents;
- (b) (i) a duty allowance of three hundred dollars;
- (ii) an entertainment allowance of three hundred dollars; and

- (iii) with effect from 1st. January, 1987 a commuted travelling allowance of one thousand two hundred and thirty-two dollars, or in lieu of such travelling allowance, shall be provided with an official car for use on official duties.

7. The Local Democratic Organs (Emoluments of Office-holders) (No. 2) Order 1981* and the Local Democratic Organs (Emoluments of Office-holders) Order 1985* are hereby revoked.
