**THE ACQUISITION OF LANDS FOR PUBLIC PURPOSES ACT,
(Cap. 62:05)**

WHEREAS by the Acquisition of Lands for Public Purposes (Utilisation or Construction of Buildings for Residential Purposes) Order 1985, No. 74 of 1985 made on the 1st day of November, 1985, the lands, buildings and erections on the land described in the Schedule to that Order were declared to be a public work under section 3 of the Acquisition of Lands for Public Purposes Act;

AND WHEREAS by the said Order the Commissioner of Lands and Surveys, together with his agents servants or workmen was authorised under section 4 of the Act to enter upon the said land for the purposes therein mentioned;

AND WHEREAS in accordance with the provision of section 6 of the Act, the report of the Chief Works Officer together with a plan of the land to be acquired was laid before the Minister;

WHEREAS the Minister has deemed it advisable to declare that the said land is required for the public work aforesaid.

NOW THEREFORE, in accordance with the provisions of the said section 6, it is hereby declared that the land described in the Schedule to this Order, is required for the public work aforesaid.

This Order may be cited as the Acquisition of Lands for Public Purposes (Utilisation or Construction of buildings for Residential Purposes).

Parcels 1949, 2307, 2311 and 2314, in Block XXX Zone E. B. D. part of North Ruimveldt, in Greater Georgetown, in the County of Demerara, State of Guyana.

Lots numbered 26, A—26, A—53, A—78, 251, 266, 348, 457, 545 and 647 parts of East La Penitence, in Greater Georgetown, in the County of Demerara, State of Guyana

Lots numbered 15, 25, 44, 49, 54 and 127, parts of Lodge Housing Scheme, in Greater Georgetown, in the County of Demerara, State of Guyana.

Lot numbered 464 part of North East La Penitence, in Greater Georgetown in the County of Demerara, State of Guyana.

Lot numbered 198, part of West Ruimveldt, in Greater Georgetown, in the County of Demerara, State of Guyana.

Lots numbered 327, 439, 488 and 636, parts of East Ruimveldt, in Greater Georgetown, in the County of Demerara, State of Guyana
