

## ORDER

## MADE UNDER

## THE BRITISH GUIANA (CONSTITUTION) ORDERS IN COUNCIL, 1953.

UNDER SECTION 4 OF THE BRITISH GUIANA (CONSTITUTION) ORDERS IN COUNCIL, 1953, IT IS HEREBY ORDERED AS FOLLOWS:—

1. The Ordinances set out in the second column of the First Schedule to this Order are hereby amended in the manner and to the extent shown in the third column of the said Schedule.

2. The Ordinances set out in the second column of the Second Schedule to this Order as amended by Order No. 49 of 1953 made by the Governor on the 2nd July, 1953 and published in the Gazette of the 18th July, 1953, are hereby further amended in the manner and to the extent shown in the third column of the said Schedule.

3. The third column of the Schedule to Order No. 49 of 1953 made by the Governor on the 2nd day of July, 1953 and published in the Gazette of the 18th July, 1953 is hereby amended—

(a) by the substitution for the word and symbol "paragraph (c)" in paragraph (c) of the amendments to section 4 of the Sea Defence Ordinance, 1933, of the word and symbol "paragraph (b)"; and

(b) by the substitution for the words 'the word "Legislature"' in the amendment to section 11 of the Public Health Ordinance, 1934 of the words 'the words "Legislature may"'. .
