

## ORDER IN COUNCIL

MADE UNDER

THE POST AND TELEGRAPH ORDINANCE,  
(Chapter 185).

UNDER SECTION 16 (2) OF THE POST AND TELEGRAPH ORDINANCE AS AMENDED BY SECTION 2 OF THE POST AND TELEGRAPH (AMENDMENT) ORDINANCE, 1945, (No. 7 of 1945), IT IS HEREBY ORDERED BY THE GOVERNOR IN COUNCIL AS FOLLOWS:—

1. This Order may be cited as the Air Mail Postages Rates Order, 1954.
2. In this Order —  
“light air letters” means air letters written on forms approved by the Postmaster General for that purpose;  
“second class mail” means printed papers, periodicals, commercial papers, samples and small packets.
3. (1) The rates of postage to be charged and paid in respect of letters, postcards, light air letters, second class mail and newspapers when addressed for transmission by air mail to the places specified in the first column of the Schedule hereto, shall be those set out in the remaining columns of the said Schedule.  
(2) The rates specified in the fourth and ninth columns of the said Schedule in respect of light air letters shall apply only where such letters contain no enclosure.
4. This Order shall come into force on the 7th day of June, 1954.

UNDER SECTION 16(2) OF THE POST AND TELEGRAPH ORDINANCE AS AMENDED BY SECTION 2 OF THE POST AND TELEGRAPH (AMENDMENT) ORDINANCE, 1945, (No. 7 OF 1945), IT IS HEREBY ORDERED BY THE GOVERNOR IN COUNCIL AS FOLLOWS :—

1. This Order may be cited as the Air Mail (Rates of Postage) (Parcels) Order, 1954.

2. The rates of postage to be charged and paid in respect of parcels addressed for transmission by Air Mail to places specified in the first column of the Schedule hereto, shall be those set out in the second and third columns of the said Schedule.

3. This Order shall come into force on the seventh day of June, 1954.

4. The Air Mail (Rates of Postage) (Parcels) Order, 1953<sup>†</sup>, and the Air Mail (Rates of Postage to Canada) (Parcels) Order, 1953<sup>‡</sup>, are hereby revoked.

ORDER  
MADE UNDER  
THE EMERGENCY ORDER

UNDER SECTION 45 OF THE EMERGENCY ORDER PREPARED IN ACCORDANCE WITH SECTION 5 OF THE BRITISH GUIANA (EMERGENCY) ORDER IN COUNCIL, 1953, IT IS HEREBY ORDERED BY THE GOVERNOR AS FOLLOWS:—

1. This Order may be cited as the Explosive Substances Order, 1954.

2. In this Order—

Cap. 30.

“County” means a police county the boundaries of which have been defined under section 33 of the Constabulary Ordinance;

Cap. 30.

“District” means a police district the boundaries of which have been defined under section 33 of the Constabulary Ordinance;

Cap. 74.

“explosive” has the same meaning as in the Explosives Ordinance.

3. For the purposes of this Order the prescribed authority for any area named in the first column of the First Schedule to this Order shall be the officer specified in the second column opposite the said area

4. (1) No person shall keep or store any explosive except in a secure place approved by the Commissioner of Police.

(2) Any person who keeps or stores, or desires to keep or store any explosives in any place shall notify the Commissioner of Police in writing through the prescribed authority that he keeps or stores, or desires to keep or store explosives in such place.

(3) The Commissioner of Police may, upon the receipt of such notification, cause such place to be examined in order to determine whether such place should be approved by him as a secure place for the keeping or storage of explosives.

5. No person shall carry, convey or use any explosive in any of the areas specified in paragraphs (a), (b), (c), (d), (e), (f) and (g) of the first column of the First Schedule to this Order without the permission in writing of the prescribed authority.

6. (1) The prescribed authority may issue permits for the purchase or acquisition of explosives, and may in such permit specify the nature, the total of explosives which may be purchased or acquired under such permit, the purposes for which the same may be used, and the place where it may be used. Such permit shall be in the Form No. 1 in the Second Schedule to this Order.

(2) A permit issued by a prescribed authority shall be valid for the period therein named, which shall not exceed twelve months, commencing on the date on which it is issued.

7. Permits under section 6 of this Order shall be made in triplicate; one copy shall be retained by the officer who issues it, and two copies shall be delivered to the person to whom it is issued.
