ORDER IN COUNCIL

THE ACQUISITION OF LANDS FOR PUBLIC PURPOSES ORDINANCE, (Chapter 179).

UNDER THE ACQUISITION OF LANDS FOR PUBLIC PURPOSES ORDINANCE, IT IS HEREBY ORDERED BY THE GOVERNOR IN COUNCIL AS FOLLOWS:—

Under section 4 or the above ordinance, the Director of Drainage and Irrigation, together with his agents, servants or workmen, is hereby authorised to enter upon the lands described in the schedule hereto for the purpose of surveying or otherwise examining such lands with a view to the acquisition of the whole or of part of any or all of such lands for the construction of a public work.

SCHEDULE

- 1 A tract of land 275 feet in width situate at Plantation Adventure, Corentyne, in the county of Berbice and bounded
 - On the North by the northern boundary of Plantation Adventure.
 - On the East by a line parallel to and distant 275 feet east of the common boundary between Plantations Adventure and Hog Stye.
 - On the South by the southern boundary of the first depth of Plantation Adventure
 - On the West by the common boundary between Plantations Adventure and Hog Stye.
- 2. A tract of land 300 feet in width situate at Plantation Epsom, Corentyne, in the county of Berbice, and bounded:—
 - On the northeast by the northeastern boundary of Plantation Epsom.
 - On the southeast by a line parallel to and distant 300 feet southeast of the common boundary between Plantations Epsom and Haversham
 - On the southwest by the southwestern boundary of the first depth of Plantation Epsom.
 - On the northwest by the common boundary between Plantations Epsom and Haversham
- 3. A tract of land 272 feet in width situate at Plantation Good Hope, Corentyne, in the county of Berbice and bounded:—
 - On the northeast by the northeastern boundary of Plantation Good Hope
 - On the southeast by a line parallel to and distant 272 feet southeast of the northwestern boundary of Plantation Good Hope adjacent to the ketting between Plantations Good Hope and Joppa.
 - On the southwest by the southwestern boundary of the first depth of Plantation Good Hope.
 - On the northwest by the northwestern boundary of Plantation Good Hope adjacent to the ketting between Plantations Good Hope and Joppa

- 4. That plot of land situate south of the public road in Plantation Kilmarnock or Lot No. 30, Corentyne, in the county of Berbice, and commencing at a point approximately 48' South of the centre line of the public road and 40' East of the eastern edge of the middlewalk trench of Plantation Kilmarnock or Lot No. 30, and extending thence North 195° 20' (true) for a distance of 315 feet thence North 128° 51' (true) for a distance of 598.5 feet thence North 15°20' (true) for a distance of 315 feet, thence North 308° 51' (true) for a distance of 598.5 feet back to the point of commencement.
- 5. A tract of land, containing an area of 4,00 English acres, on the southern side of the public road, portion of Plantation Adventure, situate on the Corentyne Coast, in the county of Berbice, measuring 200 feet in width and having a mean depth of 871.2 feet, bounded on the north by the southern boundary of the public road and on the east by a line parallel to and distant 275 feet east of the common boundary between Plantations Adventure and Hog Stye.

This Order authorises the Director of Drainage and Irrigation to enter upon the lands in question to carry out certain preliminary work.
