THE DRAINAGE AND IRRIGATION ACT

UNDER SECTION II OF THE DRAINAGE AND IRRIGATION ACT, I
HEREBY MAKE THE FOLLOWING ORDER:—

1. This Order may be cited as the Drainage and Irrigation (As-^{Citation.}
certainment) Order 1984.

3. The daily newspaper in which this Order is to be published^{Publication.}
shall be the "Guyana Chronicle".

FIRST SCHEDULE

That area of land situate on the East Bank of the Demerara
River and bounded as follows:—

On the North — By the common boundary between Craig and New
Hope from the western boundary of the East Dem-
erara Water Supply Canal, extending westwards to
the Demerara River.

On the South — By the common boundary between Plantation
Garden of Eden and the Company Path situate be-
tween Plantations Garden of Eden and Friendship
and its prolongation eastwards to the western
boundary of the reserve adjacent to and west of the
western dam of the East Demerara Water Conser-
vancy.

- On the East — By the western boundary of the reserve adjacent to and west of the western dam of the East Demerara Water Conservancy and the western boundary of the East Demerara Water Supply Canal.
- On the West — By mean low water mark on the right bank of the Demerara River from the common boundary between Craig and New Hope to the common boundary between Plantations Garden of Eden and the Company Path situate between Plantations Garden of Eden and Friendship.

SECOND SCHEDULE

That area of land situate on the East Bank of the Demerara River and bounded as follows:

- On the North — By the common boundary between Plantations Garden of Eden and Brickery and its prolongation eastwards to the western boundary of the reserve adjacent to and west of the western Dam of the East Demerara Water Conservancy.
- On the South — By the common boundary between Plantations Relief and Land of Canaan and its prolongation eastwards to the western boundary of the reserve adjacent to and west of the western Dam of the East Demerara Water Conservancy.
- On the East — By the western boundary of the reserve adjacent to and west of the western Dam of the East Demerara Water Conservancy.
- On the West — By mean low water mark on the right bank of the Demerara River from the common boundary between Plantations Garden of Eden and Brickery to the common boundary between Plantations Relief and Land of Canaan.
