THE TRADE ACT

(Cap. 91:01)

IN EXERCISE OF THE POWERS CONFERRED UPON BE BY SECTION
5 OF THE TRADE ACT, I HEREBY ORDER AS FOLLOWS:—

1. This Order, which amends the Trade (Control of Prices)^{Citation.} Order*, may be cited as the Trade (Control of Prices) (Amendment) (No. 5) Order 1983.

2. The Principal Order is hereby amended as follows:—

(i) (a) by the substitution of the particulars specified in Part A of Schedule I to this order for the corresponding particulars specified in the respective columns of Part A of the Fourth Schedule thereto; and

(b) by the substitution of the particulars specified in Part B of Schedule I to this order for the corresponding particulars specified in the respective columns of Part B of the Fourth Schedule thereto.

(ii) (a) by the insertion in the respective columns of Part A of the Fourth Schedule thereto in relation to the article numbered 5 (Powdered milk), of the particulars specified in the respective columns of Part A of Schedule II to this order; and

(b) by the insertion in the respective columns of Part B of the Fourth Schedule thereto in relation to the article numbered 5 (Powdered milk), of the particulars specified in the respective columns of Part B of Schedule II to this order.
