THE TRADE ACT

IN EXERCISE OF THE POWERS CONFERRED UPON ME BY SECTION
5 OF THE TRADE ACT, I HEREBY ORDER AS FOLLOWS:—

1. This Order, which amends the Trade (Control of Prices) ^{Citation} Order*, may be cited as the Trade (Control of Prices) (Amendment) (No. 10) Order 1983.
2. The Principal Order is hereby amended as follows:— ^{Amendment of the Principal Act}
 - (i) (a) by the substitution of the particulars specified in Part A of Schedule 1 to this order for the corresponding particulars specified in the respective columns of Part A of the Fourth Schedule thereto; and
 - (b) by the substitution of the particulars specified in Part B of Schedule 1 to this order for the corresponding particulars specified in the respective columns of Part B of the Fourth Schedule thereto.
 - (ii) (a) by the insertion in the respective columns of Part A of the Fourth Schedule thereto in relation to the article numbered 45 Soap (toilet), of the particulars specified in the respective columns of Part A of Schedule II to this order; and
 - (b) by the insertion in the respective columns of Part B of the Fourth Schedule thereto in relation to the article numbered 45 Soap (toilet), of the particulars specified in the respective columns of Part B of Schedule II to this order.
