THE ACQUISITION OF LANDS FOR PUBLIC PURPOSES ACT
(Chapter 62:05)

WHEREAS by the Acquisition of Lands for Public Purposes (Ministry of National Development) Order 1981, No. 71 of 1981 made on the 31st day of August, 1981, the land described in the Schedule to that Order together with all buildings and erections thereon was declared to be a public work under section 3 of the Acquisition of Lands for Public Purposes Act;

AND WHEREAS by the said Order the Chief Works Officer, together with his agents, servants or workmen, was authorised under section 4 of the Act to enter upon the said land for the purposes therein mentioned;

AND WHEREAS in accordance with the provisions of section 6 of the Act, the report of the Chief Works Officer and a plan of the land together with the buildings and erections thereon to be acquired were laid before the Minister;

AND WHEREAS, the Minister has deemed it advisable to declare that the said land is required for a public work;

NOW THEREFORE, in accordance with the provisions of the said section 6, it is hereby declared that the parcels of land together with the buildings and erections thereon, described in the Schedule to this Order are required for the public work aforesaid.

This Order may be cited as the Acquisition of Lands for Public Purposes (Ministry of National Development) (No. 2) Order 1983.

SCHEDULE

Those parcels of land known as N $\frac{1}{2}$ Lot 22 Stabroek and S $\frac{1}{2}$ Lot 22 Stabroek situate in the Stabroek District in the City of Georgetown in the County of Demerara, Guyana together with the buildings and erections thereon surveyed and defined on a Plan by O. Singh, Sworn Land Surveyor, dated 16th November, 1981 and recorded on 12th January, 1982 at the Department of Lands and Surveys as Plan No. 19557.

The boundaries of N $\frac{1}{2}$ Lot 22 Stabroek commence at a nail set in concrete 105' East of the centre line of Sendal Place and 54.8 feet South of the centre line of Brickdam and extend thence S15° 58' W (tr) for a distance of 95.4 feet to a wood paal branded J.E.D. thence N74° 23' W (tr) for a distance of 75.6 feet to a wood paal branded O.S. thence N15° 58' E (tr) for a distance of 95.4 feet to a wood paal branded O.S. thence S74° 23' E (tr) for a distance of 75.6 feet to the point of commencement. The said N $\frac{1}{2}$ Lot 22 Stabroek contains an area of 0.1655 acre.

The boundaries of S $\frac{1}{2}$ Lot 22 Stabroek commence at a nail set in concrete 54.5 feet North of the centre line of Hadfield Street and 27.6 feet East of the centre line of Sendal Place and extend thence N15° 58' E (tr) for a distance of 95.4 feet to a wood paal branded O.S. thence S74° 23' E (tr) for a distance of 75.6 feet to a wood paal branded J.E.D. thence S15° 58' W (tr) for a distance of 95.4 feet to a concrete paal marked J.E.D. thence N74° 23' W (tr) for a distance of 75.6 feet to the point of commencement. The said S $\frac{1}{2}$ Lot 22 Stabroek contains an area of 0.1655 acre.
