

BRITISH GUIANA

ORDER IN COUNCIL

MADE UNDER

THE DRAINAGE AND IRRIGATION ORDINANCE,  
(Chapter 192).

UNDER SECTION 11(1) OF THE DRAINAGE AND IRRIGATION ORDINANCE IT IS HEREBY ORDERED BY THE GOVERNOR IN COUNCIL AS FOLLOWS:—

1. The Drainage and Irrigation Board shall ascertain and determine whether the area or any part thereof described in the schedule hereto is suitable for and will be benefited by drainage and irrigation or drainage or irrigation.
2. The daily newspapers in which this Order is to be published shall be "The Daily Chronicle" and the "Guiana Graphic".

**SCHEDULE**

That area of land situate on the right bank of the Canje River in the County of Berbice and Colony of British Guiana the boundaries of which are as follows:—

Commencing at a point on the right bank of the Canje River at the western extremity of the southern boundary of tract "B" of Lease No. A6411 at the Port Mourant No. 2 Water Path and extending thence in an easterly direction along the southern boundary of tract "B" of Lease No. A 6411 to the eastern boundary of tract "B" of Lease No. A 6411, thence in a northerly direction along the eastern boundary of tract "B" of Lease No. A 6411 to the south-eastern boundary of tract "A" of Lease No. A 6411, thence in a north-easterly direction along the south-eastern boundary of tract "A" of Lease No. A 6411 to the south-western boundary of Lease No. A 2105, thence in a north-easterly direction along the south-eastern toe of the dam on the south-eastern side of that portion of the Port Mourant No. 2 Water Path running through Lease No. A 2105 for a distance of approximately 900 feet to the existing bend in the dam of the aforesaid Water Path thence in a northerly direction along the eastern toe of the dam on the eastern side of the Port Mourant No. 2 Water Path aforesaid running through Lease No. A 2105 to the northern boundary of Lease No. A 2105 in the rear of plantations Resource, Tain, Clifton and John on the Corentyne Coast, thence in an easterly direction along the northern boundary of Lease No. A 2105 and the prolongation thereof to the western boundary of the Bloomfield-Whim Drainage and Irrigation Area, thence in a southerly direction along the western boundary of the Bloomfield-Whim Drainage and Irrigation Area to the south-western boundary of the Bloomfield-Whim Drainage and Irrigation Area, thence in a south-easterly direction along the south-western boundary of the Bloomfield-Whim Drainage and Irrigation Area to the south-western toe of

the dam on the south-western side of the canal known as the North Branch Canal in the rear of the Black Bush Polder, thence in a south-easterly direction along a line coincident with the south-western toe of the dam on the south-western side of the North Branch Canal and the prolongation of the aforesaid line across the canal known as the Black Bush Main Canal, and the south-western toe of the dam on the south-western side of the canal known as the South Branch Canal in the rear of the Black Bush Polder to the southern toe of the dam on the southern side of the distributary known as the Yakusari Distributary at the southern boundary of the Black Bush Polder, thence by a straight line in a south-westerly direction to the north-eastern corner of Grant No. 4657 on the right bank of the Canje River, thence in a south-westerly direction along the south-eastern boundary of Grant No. 4657 aforesaid to the right bank of the Canje River, thence downstream along the right bank of the Canje River back to the point of commencement.
