THE DRAINAGE AND IRRIGATION ACT

(Cap. 64:03)

**IN EXERCISE OF THE POWERS CONFERRED UPON THE MINISTER  
BY SECTION 18 OF THE DRAINAGE AND IRRIGATION ACT,  
I HEREBY MAKE THE FOLLOWING ORDER:-**

1. This Order may be cited as the Drainage and Inigation (Declaration of Drainage and Inigation Area) (Black Bush/Block III Frontlands) Order 1979.

2. The area . of land described in the schedule is hereby declared to be a dramage and irrigation area and shall be known as Black Bush/Block III Frontlands Drainage and Irrigation

**SCHEDULE**

That area of land situate on the Corentyne Coast and known as the ~~Black Bush~~/Block III Frontlands, commencing at the intersection of the common boundary between Plantation John and Plantation Bloomfield and the Mean High Water Mark of the Atlantic Ocean with its boundaries thence in a southwesterly direction along the said common boundary between Plantation John and Plantation Bloomfield and its longahon theref to the intersection with the south-western corner of e A 8206, thence in a south-easterly direction along the southern

boundaries of Leases A 8206, A 5729 and A 5207 and their prolongation thereof to the northern extremity of the western boundary of the North Branch Canal reserve, thence in a south-easterly direction along the western boundary of the North Branch Canal reserve anti the South Branch Canal reserve to its intersection with the northern boundary of the Yakusari Canal reserve, thence in a north-easterly direction along the northern boundary of the Yakusari Canal reserve to its intersection with the western boundary of the reserve of the irrigation supply canal known as the Seaford Canal, thence in a south-easterly direction along the western boundary of the reserve of the Seaford Canal to its intersection *with* the northern boundary of Corriverton, Left Bank Corentyne River, thence in an easterly direction along the northern boundary of Corriverton to the Mean High Water Mark of the Atlantic Ocean. thence in a north-westerly direction along the Mean High Water Mark of the Left Bank Corentyne River and the Atlantic Ocean to the point of commencement, save and except the areas of land contained within the Bloomfield to Whim Drainage and Irrigation Area, the Lancaster to Manchester Drainage and Irrigation Area, the Ulverston to Salton Drainage and Irrigation Area, the Limlair to Kildonan Drainage and Irrigation Area, the frontlands of Plantations Epsom to Joppa part of the Black Bush Polder Drainage and Irrigation Area and the Lots Nos. 52 to 74 Corentyne Drainage and Irrigation Area.
