THE ACQUISITION OF LANDS FOR PUBLIC PURPOSES ACT

(Chapter 62:05)

WHEREAS by the Acquisition of Lands for Public Purposes (Demerara Harbour Bridge) Order, 1976* made on the 24th August, 1976, the proposed construction, operation and maintenance of the Demerara Harbour Bridge on the Lands described in the Schedule to that Order was declared to be a public work in accordance with Section 3 of the Acquisition of Lands for Public Purposes Act.

AND WHEREAS the Acquisition of Lands for Public Purposes (Demerara Harbour Bridge) (Variation) Order 1976** made on the 13th October, 1976 under Section 3 of the Acquisition of Lands for Public Purposes Act, varied the description of the northern boundary appearing in the Schedule to the Principal Order.

AND WHEREAS by the aforesaid Orders, the Chief Works Officer together with his agents, servants and workmen was authorised in accordance with Section 4 of the Act to enter upon the said lands for the purpose of surveying or otherwise examining such lands with a view to the acquisition of the whole or a part thereof for the construction of the public work aforesaid.

AND WHEREAS in accordance with the provisions of Section 6 of the Act, the report of the Chief Works Officer and a plan of the lands to be acquired have been laid before the Minister;

NOW THEREFORE, in accordance with the provision of the said section 6, it is hereby declared that the lands described in the Schedule to this order is required for the public work aforesaid.

This Order may be cited as the Acquisition of Lands for Public Purposes (Demerara Harbour Bridge) Order, 1977.

SCHEDULE

All those parcels of land designated as follows:-

- (i) Block "E" comprising portions of lands in Bagotstown and Peter's Hall or Land Registration Block II on the East Bank of the Demerara River;
- (ii) Blocks "A", "B" and "C" being portions of lands in Plantation Meer Zorgen on the West Bank of the Demerara River;
- (iii) Block "D" being a portion of the Demerara River between Peter's Hall/Bagotstown or Land Registration Block No. II on its East and Plantation Meer Zorgen/La Grange on its West;
- (iv) Block "Z" being a portion of land in Plantation La Grange on the West Bank of Demerara River;

situate in the County of Demerara, Republic of Guyana, and surveyed and defined on a plan by Gobin Persaud, Sworn Land Surveyor, dated 11th February, 1977 and recorded on the 25th April, 1977, at the Department of Lands and Surveys, Georgetown, as Plan No. 17508.

Block "E"

The point of commencement is at a concrete paal G.P. situate 42.10 ft. west of the centre-line of the proposed East Bank Highway and 47.60 ft. south of the centre line of the R.C. Bridge across the canal known as the "Old Shipping Place", the said 47.60 ft. being measured in a southerly direction along the centre line of the Proposed East Bank Highway.
