IN EXERCISE OF THE POWERS CONFERRED BY SECTION 5 OF THE LAW REVISION ACT, THE LAW REVISION COMMISSION, WITH THE APPROVAL OF THE PRESIDENT, HEREBY MAKES THE FOLLOWING ORDER —

Citation.

1. This Order may be cited as the Law Revision Order 1977, and may be referred to on the pages comprised in the Laws of Guyana by virtue of this Order as "L.R.O. 1/1977".

Removal and inclusion of pages. First Schedule

2.(1) The pages specified in the First Schedule are hereby directed to be removed from the Laws of Guyana with effect from the 1st July, 1977.

Second Schedule

(2) The pages specified in the Second Schedule and as laid before the National Assembly on the 3rd of June, 1977 are hereby authorised to be included in the Laws of Guyana with effect from 1st July, 1977.

Revision date of Laws.

3. It is hereby declared that the pages comprised in the Laws of Guyana by virtue of this Order state the law as in force on 1st August, 1976, except where it is otherwise stated on the pages therein.
