ORDER

MADE UNDER

THE ELECTRICITY ORDINANCE, 1957.

(No. 34 of 1957).

UNDER SECTION 28 (1) OF THE ELECTRICITY ORDINANCE, 1957, AS AMENDED BY THE ELECTRICITY (AMENDMENT) ORDINANCE, 1960, IN ACCORDANCE WITH ARTICLE 22 OF THE CONSTITUTION OF BRITISH GUIANA AND BY VIRTUE AND IN EXERCISE OF ALL POWERS ENABLING HIM IN THAT BEHALF, IT IS HEREBY ORDERED BY THE GOVERNOR AS FOLLOWS :—

1. This Order may be cited as the Electricity (Continuation of the Georgetown Electric Supply Order) Order, 1963, and shall be read with the Electricity (Commencement) Order, 1963.

2. The Georgetown Electric Supply Order made under the Georgetown Electric Supply Ordinance* shall continue in force to the extent set out in the first column of the schedule to this Order, subject to such adaptations and modifications as set out in the second column to the schedule.

Clause 1

For the words "Georgetown Electric Supply" there shall be substituted the word "Electricity".

Clause 2

The definition of "the Ordinance" shall read "the Ordinance" means the Electricity Ordinance, 1957, and any ordinance amending the same, together with the Electric Lighting Ordinance, to the extent referred to in section 26 of the Ordinance'.

The definition of "first schedule", "second schedule" and "third schedule" shall be deleted.

Clause 30

The words "If the Undertakers fail to comply with the provisions of this sub-clause they shall be liable for each offence to a penalty not exceeding twenty-five dollars" in paragraph (1) shall be deleted.

The words "and shall be a debt due from the Undertakers to the Crown and recoverable accordingly with costs" in paragraph (2) shall be deleted.

Clauses 31 to 36 inclusive.

Clause 37

The figure "(1)" at the commencement of the clause shall be deleted.

Paragraph (2) shall be deleted.

Clauses 38 to 46 inclusive.

Clause 47

For the words "this order" there shall be substituted the words "the Ordinance" in paragraph (1).

The words and comma "the Chief Secretary," in paragraph (2) shall be deleted. Paragraph (3) shall be deleted.

Clause 49

For the words "Governor in Council, the office of the Chief Secretary" there shall be substituted "Minister, the Ministry of Communications and Works" in subparagraph (a) of paragraph (1).

Clause 52

The words "but the rights privileges and franchises previously acquired by the Undertakers shall not be otherwise affected" shall be deleted.

Clause 53

The word "Minister" shall be substituted for the words "Director of Public Works" in paragraph (1) and all the words thereafter in the said paragraph shall be deleted.

Paragraph (2) and (3) shall be deleted.

Clause 54

All the words following the words "in that behalf" including the first and second provisos shall be deleted.

Clause 55

For the word "undertaking" there shall be substituted the word "Corporation".
For the word "twelve" there shall be substituted the words "twenty-five".

Clause 56

For the words "Chief Secretary" there shall be substituted the words "Postmaster General" in paragraph (2).

Clause 57

The words "or revokes" and "or revocation" shall be deleted.

Clauses 58 to 62 inclusive.

Clause 63

The words "Georgetown Electric Supply" shall be deleted.

Clauses 64 and 65

Clause 66

Paragraph (3) shall be deleted.
Paragraph (4) shall be renumbered as paragraph (3).

Second Schedule

The word "SECOND" shall be deleted.

For the words "Undertakers" and "Company" there shall be substituted the word "Corporation" and for the words "Governor in Council" there shall be substituted the word "Minister" wherever they appear in the clauses and second schedule, including the marginal notes thereof, specified in the first column of this schedule.
