IN EXERCISE OF THE POWERS CONFERRED UPON THE MINISTER BY SECTION 5 OF THE TRADE ACT, I HEREBY ORDER AS FOLLOWS:

- Citation.** 1. This Order which amends the Trade (Control of Prices) Order* may be cited as the Trade (Control of Prices) (Amendment) (No. 44) Order 1978.
- Amendment of the Principal Order.** 2. The Principal Order is hereby amended —
