THE TEACHING SERVICE COMMISSION ACT

(Cap. 39:07)

IN EXERCISE OF THE POWERS CONFERRED UPON THE MINISTER BY SECTION 13 OF THE TEACHING SERVICE COMMISSION ACT. I HEREBY MAKE THE FOLLOWING ORDER:-

1. This Order may be cited as the Teaching Service Citation and Commission (Remuneration and Allowances) Order 1978, and commenceshall be deemed to have come into operation on 10th April, 1978. ment.

2. (1) The amounts specified in Part I of the Schedule in Stallaries prescribed relation to the persons holding the respective offices specified schedule therein are hereby prescribed as the salaries payable annually to the said persons.

(2) The amounts aforesaid shall grow due and become payable monthly on the last day of each month in the year:

> Provided that the amounts to be paid for, or in respect of, each month shall not exceed the aggregate amount of all such salaries for the month, the monthly salary of a person holding an office aforesaid being onetwelfth of his annual salary.

3. (1) The amounts specified in Part II of the Schedule in Travelling relation to the persons holding the respective offices specified prescribed. therein are hereby prescribed as the travelling allowances pay- Schedule able monthly to the said persons in respect of the use of their motor cars for the purpose of performing their functions as members of the Commission.

(2) Where a member of the Commission does not own a motor car, he shall be entitled to be paid the actual travelling expenses incurred by him for the purpose of performing his functions as a member of the Commission:

Provided that the entitlement under this paragraph shall not exceed one hundred and five dollars per month.

TRAVELLING ALLOWANCES OF MEMBERS OF THE COMMISSION

In respect of the use of their motor cars for the purpose of performing their functions as members of the Commission, travelling allowances shall be paid to —

- (a) the Chairman, the Deputy Chairman and the full-time member of the Commission designated as such under section 3(7) of the Act, at the Scale 'C' rate of travelling allowance payable to public officers;
- (b) every other member, at the Scale 'B' rate of travelling allowances payable to public officers,

subject to the respective conditions of payment from time to time applying to public officers.
