SPECIAL PROVISIONS.

O. in C. 13 of 1944. (8th March, 1944.)

- 1. This order may be cited as the Shop Hours (Special Provision) (Demerara Meat Company, Limited) Order.
- 2. Without prejudice to the other provisions of the Shops Ordinance, but subject to the provisions of this order, the Demerara Meat Company, Limited, (hereinafter referred to as "the Company") is hereby permitted to be open during the hours set out in the schedule hereto.
- 3. The Company shall not employ any shop assistant in or about their business for an aggregate period exceeding eight hours on any day or forty-seven hours in any week.

SCHEDULE.

(Hours during which the company's shop may be open.)

Week-days, other than public holidays and half-

holidays 6.30 a.m. to 3 p.m. Half-holidays 6.30 a.m. to 11 a.m. Sundays 6 a.m. to 8 a.m.

- 3. Barbers shall not employ any shop assistant in or about their premises at Mackenzie for aggregate periods exceeding eight hours in any day or forty-seven hours in any week.
