IN EXERCISE OF THE POWERS CONFERRED UPON THE MINISTER BY SECTION 10 OF THE MINING ACT 1989, I HEREBY MAKE THE FOLLOWING ORDER:-

Citation and Commencement 1.

 This Order may be cited as the Guyana Geology and Mines Commission (Prospecting for molybdenum, nickel and associated minerals)
 Reservation Order 2007 and shall be deemed to have come into effect on the 18th day of September, 2007.

Reservation

2. The areas hereinafter described in the Schedule below are hereby reserved for prospecting operations by the Guyana Geology and Mines Commission for the purpose as stated in Clause 1 herein, but WITHOUT PREJUDICE to the power of the Minister (as representing the State) to permit any person to carry on in the scheduled area prospecting operations (including operations incidental thereto) for the benefit, wholly or partly, of the Guyana Geology and Mines Commission.

SCHEDULE

Tract of state land located in the Northwest Mining District No.5 and Cuyuni Mining District No.4 as shown on Terra Surveys Topographic Map 5 SW; 5SE; 6SW; 10NE; 10NW; 10SW; 10SE; 11NW, and 11SW at scale 1: 50,000 with reference point 'X' located at the confluence of the Takatu Creek and Powis Creek located with geographical co-ordinates of longitude 60° 0' 49"W and latitude 7° 26' 56"N.

Thence at true bearing of 11°, for a distance of approximately 4 miles 1214 yards, to point of commencement;

Point A, located at geographical coordinates of longitude 60°0'3"W and latitude 7°30'56"N, thence at true bearing of 89°, for a distance of approximately 39 miles 1445 yards, to Point B, located at geographical coordinates of longitude 59°25'10"W and latitude 7°31'15"N, thence at true bearing of 177°, for a distance of approximately 36 miles 66 yards, to Point C, located at geographical coordinates of longitude 59°23'23"W and latitude 7°0'0"N, thence at true bearing of 270°, for a distance of approximately 41 miles 1510 yards, to Point D, located at geographical coordinates of longitude 60°0'0"W and latitude 7°0'0"N, thence at true bearing of 0°, for a distance of approximately 35 miles 1082 yards, to the point of commencement at Point A.

Thus enclosing an area of approximately 935,765 acres, save and except all lands lawfully held or occupied.
