THE FOLLOWING ORDER:-**


Citation and Commencement.

1. This Order may be cited as the Restriction of Rights (Mining Lands) Order 2007 and shall be deemed to have come into operation on the 1st day of July, 2007.

**Extension of restriction to permit
holders, etc.**

2. All holders of claim licences, prospecting permits (small and medium scales) and mining permits shall from the aforesaid date be subject to the provisions of sections 81 to 87 (inclusive), with such modifications qualifications or exceptions as may be specified therein.
