Made Under
THE MINING ACT
(No. 20 of 1989)

IN EXERCISE OF THE POWERS CONFERRED UPON THE MINISTER BY
SECTION 10 OF THE MINING ACT 1989, I HEREBY MAKE THE
FOLLOWING ORDER:-

- Citation and Commencement** 1. This Order may be cited as the Guyana Geology and Mines Commission (Prospecting for Radioactive Minerals and Rare Earth Elements) Reservation Order 2006 and shall be deemed to have come into effect on the 2nd May, 2006.
- Reservation** 2. The areas hereinafter described in the Schedule below are hereby reserved for prospecting operations by the Guyana Geology and Mines Commission, but **WITHOUT PREJUDICE** to the power of the Minister (as representing the State) to permit any person to carry on in the scheduled area prospecting operations (including operations incidental thereto) for the benefit, wholly or partly, of the Guyana Geology and Mines Commission.

SCHEDULE

Area A

Tract of state land located in the Mazaruni Mining District No. 3 as shown on Terra Surveys Topographic Map 23NE, within the following boundaries;

Commencing from:

Point 1, located at geographical coordinates of longitude 60°46'0"W and latitude 6°42'25"N, thence at true bearing of 140°, for a distance of approximately 21 miles 961 yards, to Point 2, located at geographical coordinates of longitude 60°34'0"W and latitude 6°28'0"N, thence at true bearing of 180°, for a distance of approximately 18 miles 1520 yards, to Point 3, located at geographical coordinates of longitude 60°34'1"W and latitude 6°11'37"N, thence at true bearing of 38°, for a distance of approximately 11 miles 1650 yards, to Point 4, located at geographical coordinates of longitude 60°40'24"W and latitude 6°19'49"N, thence at true bearing of 14°, for a distance of approximately 26 miles 1419 yards, to the point of commencement at Point 1.

Thus enclosing an area of approximately 124,477 acres, save and except all lands lawfully held or occupied.

Area B

Tract of state land located in the Rupununi Mining District No.6 as shown on Terra Surveys Topographic Map 50NE, within the following boundaries;

Commencing from:

Point 1, located at geographical coordinates of longitude $59^{\circ}10'0''\text{W}$ and latitude $5^{\circ}12'0''\text{N}$, thence at true bearing of 125° , for a distance of approximately 11 miles 1180 yards, to **Point 2**, located at geographical coordinates of longitude $59^{\circ}1'40''\text{W}$ and latitude $5^{\circ}6'11''\text{N}$, thence at true bearing of 215° , for a distance of approximately 27 miles 1040 yards, to **Point 3**, located at geographical coordinates of longitude $59^{\circ}15'29''\text{W}$ and latitude $4^{\circ}46'35''\text{N}$, thence at true bearing of 12° , for a distance of approximately 29 miles 1666 yards, to the point of commencement at **Point 1**.

Thus enclosing an area of approximately 103,041 acres, save and except all lands lawfully held or occupied.

Area C


Tract of state land located in the Rupununi Mining District. No.6 as shown on Terra Surveys Topographic Map 54NE, within the following boundaries;

Commencing from:

Point 1, located at geographical coordinates of longitude $59^{\circ}40'9''\text{W}$ and latitude $4^{\circ}21'45''\text{N}$, thence at true bearing of 129° , for a distance of approximately 6 miles 1326 yards, to **Point 2**, located at geographical coordinates of longitude $59^{\circ}35'33''\text{W}$ and latitude $4^{\circ}18'6''\text{N}$, thence at true bearing of 35° , for a distance of approximately 5 miles 452 yards, to **Point 3**, located at geographical coordinates of longitude $59^{\circ}32'56''\text{W}$ and latitude $4^{\circ}21'51''\text{N}$, thence at true bearing of 269° , for a distance of approximately 8 miles 497 yards, to the point of commencement at **Point 1**.

Thus enclosing an area of approximately 11,337 acres, save and except all lands lawfully held or occupied.
