#### Abstract

IN•EXERCISE OF THE POWERS CONFERRED UPON ME BY SECTIONS 3 AND 4 OF THE ACQUISITION OF LANDS FOR PUBLIC PURPOSES ACT, I HEREBY MAKE THE FOLLOWING ORDER:-


Citation.

Land declared a public work.

Authority to enter and examine the land.

1. This Order may be cited as the Acquisition of Lands for Public Purposes (Access roadways to the Berbice River Bridge) Order 2006.
2. The proposed construction of the access roadways to the Berbice River Bridge on the land described in Schedules I, II, and III is hereby declared to be a public work.
3. The Commissioner of Lands and Surveys, together with his agents, servants or workmen are hereby authorised to enter upon the said land for the purpose of surveying or otherwise examining the land with a view to the acquisition of the whole of it for the public work
