 This Order may be cited as the Guyana Geology and Mines Commission (Prospecting for Gold and Valuable Minerals) Amendment Order 2006 and shall come into effect on the 24th October, 2006.

- 2. The citation with respect to Order no. 50 of 2005 for the area as described herein below is hereby amended to read as follows "The Order may be cited as the Guyana Geology and Mines Commission (Prospecting for Uranium, Radioactive Minerals, and Rare Earth Elements) Reservation Order 2005".
 - 3. The area described herein below is hereby declared open for application for licences and permits for minerals other than radioactive elements, rare earth elements and uranium.

<u>SCHE</u>DULE

Tract of State Land located in the Potaro, Mazaruni and Cuyuni and Mining Districts Nos. 2, 3and 4 as shown on Terra Surveys Topographic Maps 15SW/SE/NE, 16SW, 23NE, 24NW/SW/SE, 25SW, 33NE, 34NW/NE/SW/SE, 35SW, 42NE, 43NW/NE/SE and 44SW within the following boundaries:
