## **ORDER**

## THE PRESIDENT'S COLLEGE ACT 1990

## (No. 11 of 1990)

IN EXERCISE OF THE POWERS CONFERRED UPON THE MINISTER BY SECTION 22 OF THE PRESIDENT'S COLLEGE ACT 1990, I HEREBY MAKE THE FOLLOWING ORDER:—

1. This Order may be cited as the Tertiary Technical and Vocational Institutions (Board of Governors) Order 1993 and shall come into operation on 1st September, 1993.

Citation and commencement:

2. In this Order "technical institutions" means the tertiary technical and vocational educational institutions mentioned in clause 3 (3).

Interpre

3. (1) The provisions of the Act, other than sections 1, 2, 3 (1) and 22, shall mutatis mutandis apply in relation to the technical institutions mentioned in paragraph (3) and for that purpose shall be read and construed with any necessary modifications, and, without prejudice to the generality of the foregoing, subject, in particular for the purpose of such application to the modifications in paragraph (4).

Application of certain provisions of the Act.

- (2) Each of the technical institutions mentioned in paragraph (3) shall be administered and maintained by a Board of Governors which shall be a body corporate.
- (3) The technical institutions mentioned in the preceding paragraphs are the Tertiary Technical and Vocational Educational Institutions, namely:—
  - (a) Government Technical Institute;
  - (b) New Amsterdam Technical Institute;
  - (c) Guyana Industrial Training Centre;
  - (d) Carnegie School of Home Economics.

(4) The following are the modifications referred to in paragraph (1) —

for sections 7, 8, 9 and 13 the following sections shall respectively be substituted —

"Objectives of technical institutions,

- 7. The objectives of the technical institutions are
  - (a) to offer education and training in technical subjects in both day and evening classes to persons (including the handicapped) fifteen years and above;
  - (b) to ensure as far as possible, that graduates from a technical institution can enter directly into industry, and perform with the minimum of further, orientation;
  - (c) to liaise with Industry, Commerce and interested agencies, to assess their needs and adjust course contents and subject areas in an attempt to satisfy their needs by the output of students;
  - (d) to conduct special training courses as the necessity arises in the community, and as the financial position would allow.

Eligibility,

8. Students who are citizens of Guyana shall be eligible for admission to a technical institution.

Admission of students,

9. No student shall be admitted to a technical institution unless he has attained the required age and qualifications as determined by the Minister,

Vesting of assets in Board of Governors,

13. The assets (whether movable or immovable property, including rights and interests) belonging to the State in relation to each of the technical institutions to which this Order applies are hereby vested in the Board of Governors of that technical institution.".
