IN EXERCISE OF THE POWERS CONFERRED UPON ME BY SECTION 1 OF THE COMPANIES ACT, 1991, I HEREBY MAKE THE FOLLOWING ORDER:-

IN EXERCISE OF THE POWERS CONFERRED UPON ME BY SECTION 8 OF THE CUSTOMS ACT, I HEREBY MAKE THE FOLLOWING ORDER:-

1. This Order, which amends the First Schedule to the Customs Act, may be cited as the Customs Duties (Amendment) Order 1995 and shall come into operation on the 1st July, 1995.

Citation and commencement. Cap. 82:01


