IN EXERCISE OF THE POWERS CONFERRED UPON ME BY SECTIONS 9 AND 50 OF THE LOCAL DEMOCRATIC ORGANS ACT 1980, I HEREBY MAKE THE FOLLOWING ORDER:—

1. This Order, which amends the Local Democratic Organs (Emoluments of Office-holders) Order 1989*, may be cited as the Local Democratic Organs (Emoluments of Office-holders) (Amendment) Order 1995 and shall be deemed to have come into operation on 1st January, 1995.

Citation, and commencement,

2. Clause 5 of the Principal Order is hereby amended in the following respects —
