**THE PENSIONS (PRESIDENT, PARLIAMENTARY AND SPECIAL  
OFFICES) ACT**

(Cap. 27:03)

IN EXERCISE OF THE POWERS CONFERRED UPON ME BY SECTION 2  
OF THE PENSIONS (PRESIDENT, PARLIAMENTARY AND SPECIAL  
OFFICES) ACT, I HEREBY MAKE THE FOLLOWING ORDER:—

1. This Order may be cited as the Pensions (President, Parliamentary and Special Offices ) (Designation) Order 1992. Citation.

2. The offices of Director, Workers Education and that office as renamed as Workers Education Consultant, from time to time within a number of Ministries of the Government, are designated as specified qualifying offices for the purposes of the Act. Specified  
qualifying  
office.

3. Notwithstanding clause 2, service in the offices mentioned in that clause between 13th December, 1985, and the 15th November, 1991, shall be service as a legislator for the purposes of the Act only if service as Director, Workers Education was preceded by service of the holder thereof in such other office as would qualify to be reckoned as service as a legislator for the purposes of the Act. Service.
