THE ACQUISITION OF LANDS FOR PUBLIC

PURPOSES ACT

(Cap. 62:05)

WHEREAS by the Acquisition of Lands for Public Purposes (Construction of Public Road) Order No. 57 of 1991 made on the 8th day of October, 1991 the proposed construction of a public road on the land described in the Schedule to that order was declared to be a public work under section 3 of the Acquisition of Lands for Public Purposes Act;

AND WHEREAS by the said Order the Commissioner of Lands and Surveys, together with his agents, servants and workmen, was authorised under section 4 of the Act to enter upon the said land for the purposes therein mentioned;

AND WHEREAS in accordance with the provisions of section 6 of the Act the report of the Commissioner of Lands and Surveys together with a plan of the land to be acquired was laid before the Minister.

AND WHEREAS the Minister has deemed it advisable to declare that the said land is required for the public work aforesaid;

NOW THEREFORE, in accordance with the provisions of the said section 6, it is hereby declared that the strip of land as shown on the said plan, described in the Schedule to this Order, is required for the public work aforesaid;

This Order may be cited as the Acquisition of Lands for Public Purposes (Construction of Public Road) (No. 2) Order 1992;

SCHEDULE

A strip of land being a portion of Plantation Klien Pouderoyen situate on the West Bank Demerara River, County of Demerara, Guyana, which is shown and defined on a Plan by R. N. Durbeej, Sworn Land Surveyor, dated 5th March, 1992 and recorded in the Department of Lands and Surveys as Plan No. 23985.
