### THE PUBLIC CORPORATIONS ACT 1988

IN EXERCISE OF THE POWERS CONFERRED UPON ME BY SECTION 8 OF THE PUBLIC CORPORATIONS ACT 1988, AS APPLIED TO GUYANA RICE MILLING AND MARKETING AUTHORITY UNDER SECTION 66 OF THAT ACT, I HEREBY MAKE THE FOLLOWING ORDER:—

1. This Order may be cited as the Guyana Rice Milling and Marketing Authority (Transfer of Property) (No. 5) Order 1992 and shall come into operation on September 3, 1992.
